### **Community Living Committee**

- Fatica Ayers, Committee Staff, reported that the committee had two action items:
  - 1) Committee voted to reappoint Renee Wood for special advisor of the Community Living Committee for the 2019 grant year.
  - 2) 2018 State Plan Amendment to allow the Ohio Alliance of Direct Support Professionals to pay for the expenses to be incurred for the Grantee Gathering which will be held on October 31, 2018. The Amendment calls for an increase in the amount of **\$1,683.00** for audio visual, rental fees, CART Services and lunch.

### **Executive Committee**

- Carolyn Knight reported that Ohio SIBS requested **\$5,000** to assist with scholarships to individuals and family members who cannot pay the **\$125** registration fee for the annual 2018 Ohio SIBS Conference on November 2-3, 2018. Carolyn stated that because the amount requested was **\$5,000**, it would require full Council to approve. A roll call vote was done, and motion passed.

### **Nominating Committee**

Chairman Joanna Spargo turned the meeting over to Council staff Paul Jarvis to report the Nominating Committee action items. Paul informed Council members that there will a roll call vote due to Susan Willis being on a teleconference. He then asked Council if they would prefer to vote on each recommendation provided separately or as a group for the 2018 new membership? Council agreed to vote on the recommendations a presented by the Nominating Committee as a group. The following recommendations were as follows:

Rochelle Hall-Rollins moved to approve submission of the recommendations provided. Michael Richards seconded the motion. A **roll-call** vote was conducted, and the **motion** passed. Another **roll-call** vote was conducted for Vice Chair, Karen Kerr received 9 votes, Jill Radler received 3 votes,

and Victor Wilson received 3 votes. Karen Kerr received the highest votes and was appointed Vice-Chair to begin her new position in January 2019. Another vote was taken for Secretary. Dara Walburn received 11 votes, Blaine O’Leary received 2 votes, and Marcella Straughter received 3 votes. - Mike Schroeder reminded the Council about the upcoming NADD Conference in Ohio on September 24 -25, 2018.


