initiative for the Ohio DD Council. It is our mission to identify, approach, and have conversations with groups to discuss issues we could assist in the future. The federal government is enquiring if councils are reaching out to communities they might not have in the past. This is in addition to requesting data on people who receive limited services or are in an unserved/underserved population. The Ohio DD Council's Outreach Committee is in the process of addressing these new communities as should all council committees.
